Saint Mark's Lion

The Venetian lion normally has wings, very often holds a book below its paw, and sometimes is completed by a halo around its head. These three elements (wings, book, halo) reveal it as a symbol of Saint Mark the Evangelist, patron saint of the city.

According to a tradition started in the 2nd century AD, each of the four Evangelists is represented by a winged creature: lion, bull, eagle, human. This set of four creatures was also used in relation with the divine presence in the Old Testament.

Also, the lion has been associated with power, courage and strength since ancient times. What better symbol for the prestigious Venetian Republic?

"Pax tibi Marce"

So, now we know that the book the lion is holding stands for the gospel of Saint Mark.

Have you tried to read the Latin sentence written in it?

It says "Pax tibi Marce, evangelista meus", which translates as "Peace to you Mark, my evangelist". According to legend, while Saint Mark was visiting the Venetian lagoon in the 1st century AD, a storm put him in danger, but an angel appeared to him and reassured the saint with those words.

REPORT OF THE PASTOR Reverend Brian Vasey

Annual Report of the Pastor (2023)

I am the true vine, and my Father is the vine grower. He removes every branch in me that bears no fruit. Every branch that bears fruit he prunes to make it bear more fruit. You have already been cleansed by the word that I have spoken to you. Abide in me as I abide in you. Just as the branch cannot bear fruit by itself unless it abides in the vine, neither can you unless you abide in me. I am the vine, you are the branches. Those who abide in me and I in them bear much fruit, because apart from me you can do nothing. (John 15:1-5)

Traditionally when we hear or read this text we interpret "abide" to mean, "rest; to be at peace; to be comforted". Certainly abide has that connotation. But it also communicates to us an activity in the living of life. Jesus teaches us that when we abide in him we bear much fruit. To abide in Jesus therefore means not only to rest and be comforted, but also "to do"; to be his hands and feet; to respond as Jesus would respond; to be the church!

In 2023 this congregation known as St. Mark's Lutheran Church has responded to this call of our Lord. We have "abided" in Christ and thus have "borne fruit":

- + We have remembered the promise that comes to us in Christ; the promise of God's love for us and all people as the church through worship and Christian Education (Sunday School and Small Group Study). We identify as, "The community of believers and saints brought together by the Holy Spirit for the preaching of the Word and the administration of the holy sacraments in accordance with the Gospel (Augsburg Confession VII)."
- + We have proclaimed the Good News of Christ and in Christ here and abroad through the support of our synod and various ELCA Missionaries and Missions.
- + We have participated in the ministries of Operation Christmas Child, Church World Service (CROP Walk), Lutheran World Relief and Heifer Project International.
- + We have offered prayers, practical help, medicine and food to neighbors near and far by supporting Diakon Ministries, Family Promise of Lycoming County, the City Ministerium of

Williamsport, the United Churches of Lycoming County, and Lutheran Disaster Response.

This is who we are. This is whose we are. We are the church. We are the Body of Christ. We minister because Christ has ministered to us. If we cease to minister because of anything- COVID 19 (which is still with us), the current wars in Ukraine and Israel, lack of funds, apathy- we cease to be the church, we cease to be the people of Christ.

On Sunday, December 3, we began the Season of Advent and thus a new Church Year. Advent is an opportunity to look at the past with fondness and thanks and to the future with hope. Many of our accomplishments in 2023 should be looked at with great satisfaction: Resolving "what time to have worship" with dignity and respect for each other; exploring Christian Education taking place at other times than just on Sunday morning; a more intentional relationship with "Little Lambs" pre-school; exploring ways to use our building as good stewards while respecting it as "holy space". Yes, we have accomplished a great deal in ministering in our Lord's name in 2023. Many have made this reality: The leadership and officers of our Church Council, Committees, and Church Staff both paid and volunteer; the warmth and continued caring of members and friends of our congregation. As pastor I thank you for your work on behalf of Christ for the sake of the world. We have much for which to give thanks and praise to God! But at the same time we realize we should not, we cannot rest only on past laurels. We need to move forward in the hope of Christ. We will!

Martin Luther said many times in his ministry, "Have faith! Grace abounds!" We go forward in this new church year ever clinging to the promises of God through Christ the vine. In him we have and will continue to abide and bear much fruit. With the guiding of God's own Spirit we will continue to know Christ and to make Christ known.

REPORT FROM THE DIRECTOR OF MUSIC Sam Robinson

Report from the Director of Music

The passage of time continues to amaze. I find it hard to believe that 2024 will be my fourth year at St. Mark's. I am so grateful for the opportunity to share music with the congregation every week, and I look forward to many more years of service.

This fall, we continued to welcome four choral singers to the 10:30am service: Alanna Ramos, Olivia Ciabattari, Chase Bower, and William Ciabattari. These gifted musicians have allowed us to continue with high quality choral anthems on selected Sundays. We look forward to increasing the number of Sundays with choral music in 2024.

Currently, the Mighty Möller requires some large and costly repairs to revitalize its full potential. There are several "dead" (inoperable) notes throughout the organ. There are several reasons why this happens in a pipe organ. First, this organ is an electro-pneumatic instrument, which means that there are several relay boards that send a signal from the organ console to the pipes to create a sound. Right now, one of our internal relays is failing. Because of this, certain pipes are not reliably getting the signal to play at the right time. Parsons (our organ builder) is recommending a new solid-state relay that will replace the deteriorating existing one. In 2016, they completed this work on another division of the organ.

The other principal reason for dead, inoperable notes is a result of worn-out leathers. There are thousands of leather components of an organ. Pneumatic actions have either a small, circular leather pouch or a tiny leather-covered bellows for every pipe in the instrument. These allow air pressure to open and close the valve underneath each pipe. Joints in the wooden wind chests are gasketed with leather strips. Wooden pipes that have movable stoppers use leather as packing so that the stopper is airtight. Reservoirs and bellows are jointed or hinged with strips of leather. Leather lasts a long time in an organ, usually about 50 years. Parsons is recommending the replacement of certain leather pieces that are no longer functioning properly—all of which are over 60 years old from the installation in 1959. They have served us well, but it is time for some major work.

Aside from the building itself, the Möller Organ may be the church's largest and most valuable asset. It serves the congregation and the community every week of the year without fail. In this community, there is no organ that compares to the versatility, the magnificence, and reliability of our Möller. We are blessed to have this instrument at St. Mark's, and I am beyond blessed to have the opportunity to play it week after week. Please see the attached recommendations from Parsons for more specifics on the repairs needed to the organ. I hope my above words were helpful in translating some of the organ-specific language.

Building security has been improved through regular maintenance with ACE Lock Co. to ensure that exterior doors are closing properly. The congregation is reminded that when exiting the building that each person should check the door to be sure it is properly closed and locked. Additionally, security cameras were recommended by church council for the exterior of the building. Therefore a number of cameras and a recording device have been purchased and installed through CompuGen to provide video surveillance of our church and parish house. Additionally, audio/video doorbells are being installed at the office and fellowship hall doors, to make it easier to speak with visitors.

After a minor fire occurred in Front lounge, it was determined to enhance our current fire response by adding 2 fire extinguishers, and updating signage in each room to indicate the location of the closest extinguisher.

The AED (Automated External Debrillator) in-service was held in September, to review its proper use and how to respond to a medical emergency.

PROPERTY COMMITTEE

The purpose of the Property Committee is to proclaim Jesus Christ to each other and all the world by promoting the use of the congregation's physical resources in the support of our Christian Mission. To this end the committee arranged for the promotion, protection, maintenance, repair and expansion of church properties. The Committee supervises the use of the same by the congregation and other organizations so that the facilities are adequate for the functions assigned by the congregation.

The year 2023 posed a number of challenges at St Mark's as we continue to address maintenance needs for the church's large and aging infrastructure.

- -Roof- a number of leaks required attention and to better keep ahead of future problems a long term roofing maintenance contract was entered with R H Macron.
- -HVAC- Several concerns were addressed related to cooling in Fellowship Hall, and the aging boiler for the Parish House.
- -Exterior Grounds- The diligent and routine care by Doc. Albright, Tim Maggs, and others was assisted by landscapers from Vandelinde. Parking lot lighting was repaired, and patching of asphalt cracks completed by M&M Paving.

The investigation for the repair of the tower spire has proven complex and challenging. With at least 3 mechanical failures since the church was built, a new approach is required. A structural engineer is working to give us options that will hopefully allow both an aesthetic and structurally sound solution.

We ask for the congregation's insight and prayer as we hope to find a suitable person to work as our church sexton. Choice Cleaning continues to perform the cleaning duties keeping the building orderly.

We appreciate the time and talents of the other active members of the committee, including Herb Poff, Dave Williams, Bob Miller, Glenn Yaple, Deb Buckman, and Jim & Susan Newcomer.

As we look ahead to 2024 there are a number of projects and repairs, big and small, that we will endeavor to tackle as we strive to preserve and promote the physical space that is the church of St Mark's.

UPDATE ON DOSSAL REPLACEMENT PROJECT

Dossal Replacement: An Update for 2023

Replacement of the dossal cloth behind the altar was first discussed at the February 2020 Council meeting. Council members (and others) noticed that the current white dossal cloth was becoming noticeably dirtier and, in many places, torn and frayed; it needed to be addressed.

At that meeting, Council approved using red fabric when the dossal was replaced again. This was the color originally chosen by the award-winning architect, T. Norman Mansell, who designed our church. It adds some warmth to the chancel and offsets the coolness of the two larger grey screens (one on either side of the dossal) on which the wooden plaques are hung.

We are pleased to report that we are making progress with the dossal replacement project. The current dossal cloth is made up of 21 panels that together create a white backdrop for the suspended cross. The area is approximately 11 feet wide x 36 feet high. It features two multi-color orphreys or bands, one on either side of the dossal. One plan would be to replace the current fabric with red cloth and to reinstall the frames.

A second plan would be to revert to the architect's original design, that of a continuous red cloth from ceiling to floor. Many of the fabrics used for dossal cloths come in widths of 55 to 60 inches. Three sections of fabric would be sewn together to create a single red dossal, taking careful measures to align any patterns in the cloth. Mr. Mansell chose blue as the color for the original two orphreys.

Several companies are able to provide the fabric. While we had hoped to have the cloth replaced by this past year, there was a major setback in finding a company to install the dossal. After looking at several options, we contacted Lundy Construction Company, Williamsport. Following their evaluation, they are certain that they can help us with that part of the project.

St. Mark's is blessed to have a beautiful worship space. Our nave was thoughtfully designed more than 60 years ago and continues to serve us well. The Worship and Music Committee is being deliberative as it seeks ways to assure that our facility retains its splendor. We appreciate your patience and understanding, as well as your thoughts and support.
